

# Scholarships, Bursaries, Prizes and Financial Aid

The Student Awards Office is responsible for the administration of all forms of financial assistance for undergraduate students. The office administers the University's scholarship and bursary programs under the direction of the Senate Committee on Academic Regulations and Awards, the Ontario Student Assistance Program (OSAP), other federal/provincial student assistance programs, and an emergency loan fund. Payment of awards is subject to the availability of funds. Where possible clients with mobility issues will not be required to line-up and will be dealt with on a priority basis.

## Guidelines for Scholarships Administration

Laurentian University undergraduate program recognizes and rewards academic excellence of students who are registered in a full time course load, and who pay tuition fees to Laurentian University.

Not all scholarships are necessarily awarded each year. Payment of awards is subject to the availability of funds. To ensure that scholarships are equitably distributed, Laurentian University reserves the right to restrict the value of scholarships that any one student may receive.

Awards will be applied directly to students' fee accounts. In the event that the scholarship has a total value exceeding the amount of fees, or that fees have already been paid in full, a refund will issued to the student.

Eligibility will be confirmed in October, and awards paid out at the end of October annually.

## MAJOR SCHOLARSHIPS

Major scholarships include the Chancellor's Scholarship, President's Scholarship, Dean's National Scholarship.

Students who receive major scholarships are not entitled to receive an Academic Excellence Award, Community Service Bursary, or Leadership Award.

## **ENTRANCE SCHOLARSHIPS**

Scholarships, prizes, awards and medals are based primarily on academic performance and are generally given to students in full-time attendance with first-class standing. Canadian citizenship or permanent resident status is a mandatory criterion.

*Unless otherwise specified, applications for entrance scholarships are **not** required since they are awarded on academic merit. Application deadline is **March 1st of each year**. Not all awards need to be awarded each year. The University may withdraw any award for which, in any year, no qualified applicant is found. In order that scholarships and bursaries may be equitably distributed, the committee reserves the rights to restrict the value of scholarships that any one student may receive. The committee also avoids the awarding of multiple scholarships wherever possible. **Apply on-line - Application deadline: March 1<sup>st</sup>**

#### **Jim Fielding Memorial Bursary**

Value: \$60,000 - maximum of \$15,000 per year and renewable for three years (equivalent to the cost of tuition, cost of residence (if applicable), Super Saver Meal Plan and cost of books and equipment). Established by his children, Norinne, Murray and Craig. Mr. Jim Fielding was born, raised and lived his life in the Sudbury area. He was proud to be a member of a large well known area family and he relished every opportunity to be in attendance at numerous family occasions. Jim held the position of Chairman of the Board of Alexander Centre Industries Ltd. (ACIL), Waters and associate companies. Further, he was elected as Director of Canadian Pacific on May 7<sup>th</sup>, 1986 and continued serving in that capacity through to his successful re-election in April 2000. He also had a passion for learning. He was highly respected in the business community, known as a caring and considerate employer who was always interested in others. This bursary was created to provide students with an opportunity to attend university and realize their fullest potential. It will be awarded to students who may have struggled academically because of financial and personal challenges that have limited their ability to concentrate on their studies. Students must be nominated by a teacher, guidance counsellor or professional speaking on their potential and background. Preference will be given to students pursuing applied studies. Recipients cannot be eligible to hold any other awards with a value of \$1,000 or more. To renew the

scholarship, students must satisfy the passing grade requirements of their degree, maintain full-time status, and complete 30 credits (the normal academic workload) in a 12 month period to be eligible to renew the bursary. Nomination and application form is required.

### **National Deans' Entrance Scholarship for Excellence**

Value: \$20,000/ea (\$5,000 renewable for three years). One scholarship will be awarded in each of the Faculties: Arts - Humanities, Arts - Social Sciences, Professional Schools, Sciences and Engineering, and Management.

To be eligible, students must: present a minimum of 90% on 6 best 4 U/M courses or equivalent, including required courses for his or her program, have made a significant contribution to his or her school and community, and have demonstrated leadership qualities.

The award includes a mentorship with the Dean of the Faculty or a distinguished member selected by the Dean. Recipients will be required to participate in a minimum of 2 approved Laurentian University events or activities, e.g. Open House, Donor reception, etc. To renew the scholarship, students must achieve an 80% average in subsequent year. Application required. One of the five winners of a National Deans' Scholarship will be chosen to receive the Dr. Judith Woodsworth President's scholarship valued at \$1000, renewable provided the recipient meets the renewal criteria for the National Deans' Entrance Scholarship for Excellence program. Please arrange to have two letters of recommendation forwarded directly to Laurentian University. One should be from a teacher or guidance counsellor and the other from a member of the community. Application required.

### **Chancellor's Scholarship**

Value: \$40,000 (over 4 years). To be eligible, students must: present a minimum of 90% on 6 best 4 U/M courses or equivalent, including required courses for his or her program, have made a significant contribution to his or her school and community, and have demonstrated leadership qualities. The award includes a guarantee of a single room (residence application required and residence fees applicable). Recipients will be required to participate in a minimum of 2 approved Laurentian University events or activities, e.g. Open House, Donor reception, etc. To renew the scholarship, students must achieve an 80% average in subsequent year. Please arrange to have two letters of recommendation forwarded directly to Laurentian University. One should be from a

teacher or guidance counsellor and the other from a member of the community.  
Application required.

### **President's Scholarships (2)**

Value: \$30,000 (over 4 years). To be eligible, students must: present a minimum of 90% on 6 best 4 U/M courses or equivalent, including required courses for his or her program, have made a significant contribution to his or her school and community, and have demonstrated leadership qualities. The award includes a guarantee of a single room (residence application required and residence fees applicable).

Recipients will be required to participate in a minimum of 2 approved Laurentian University events or activities, e.g. Open House, Donor reception, etc. To renew the scholarship, students must achieve an 80% average in subsequent year. Please arrange to have two letters of recommendation forwarded directly to Laurentian University. One should be from a teacher or guidance counsellor and the other from a member of the community. Application required.

### **Aboriginal Studies Excellence Awards**

Value: \$1500. To be eligible, students must: present a minimum of 80% on 6 best 4 U/M courses or equivalent, including required courses for his or her program, and have successfully completed one Grade 11 or Grade 12 credit in Native Languages or Native Studies. Application required.

### **French Immersion Excellence Awards**

Value: \$1000. To be eligible, students must: present a minimum of 80% on 6 best 4 U/M courses or equivalent, including required courses for his or her program, and have graduated from a French Immersion or Extended French high school program. Students must register in a minimum of 2 three credit courses taught in the French language. Application required.

### **Leadership Awards**

Value: \$1000. The Leadership Awards Program acknowledges and encourages the outstanding school and community leadership contribution of students. To be eligible, students must: present a minimum of 75% on 6 best 4 U/M courses or equivalent, including required courses for his or her program, have made a significant contribution to his or her school and community, have demonstrated leadership qualities. Application required. Please arrange to have two letters of recommendation forwarded directly to Laurentian University. One should be from a teacher or guidance counsellor and the other from a member of the community.

### **Community Service Bursaries**

Value: \$4000 over 4 years. To be eligible, students must: present a minimum of 80% on 6 best 4 U/M courses or equivalent, including required courses for his or her program, have made a significant contribution to his or her school and community, have demonstrated leadership qualities, and have financial need. Recipients will be required to participate in a minimum of 2 approved Laurentian University events or activities, e.g. Open House, Donor reception, etc. To renew the scholarship, students must achieve an 80% average in subsequent year. Application required. Please arrange to have two letters of recommendation forwarded directly to Laurentian University. One should be from a teacher or guidance counsellor and the other from a member of the community.

### **Access to Opportunities Bursary**

Value: \$1000. The Access to Opportunities Bursaries are non-repayable awards offered to students who demonstrate financial need. Application required.

### **Sudbury Construction Association Architecture Scholarship**

Value: \$2,500. The Sudbury Construction Association (SCA) began in 1948 with a solid foundation – the skills and experience of local contractors and trades people. Today, the Sudbury Construction Association is an ICI association supporting contractors, manufacturers & suppliers, service providers, consulting firms, and training and personnel providers. The Sudbury Construction Association promotes member interests and provides specialized services to help more than 270 members compete and succeed.

As soon as the concept of bringing a School of Architecture to downtown Sudbury and Laurentian University was created, the Sudbury Construction Association was quick to lend its support. The SCA was the first association to create a scholarship to help attract bright, young architects to Northern Ontario.

This scholarship is awarded annually to one full-time student, who is a Canadian citizen or permanent resident, entering the first year of the School of Architecture at Laurentian University. Preference will be given to a student who demonstrates academic merit. Value of the award is \$2,500. Selection of the award recipient shall be made by the Student Awards Office at Laurentian University. Application required.

### **Jacqueline Labelle Award**

Value: \$1,000

Recipient: Full-time student entering the first year of any program, on the basis of academic excellence, financial need and Ontario residency as defined by OSAP. Candidates must be graduates of École secondaire catholique

Horizon. Selection is made on the recommendation of the secondary school. Application required.

### **Pada Memorial Award**

Established by the Pada family, friends and associates, in memory of a fine gentleman and noted CVRD-Inco geologist, Vishnu Pada. He and his two daughters, Brinda and Arti, died tragically in the crash of Air India flight 182 in 1985. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP.; the recipient must be a graduate student from Marymount Academy Secondary School. If no qualified applicant is chosen from Marymount Academy Secondary School, the bursary will be awarded to a full-time Geology Student at Laurentian University. Value: \$500. Application required.

### **Laurentian University Federation Memorial Award**

Laurentian and its federated institutions created the Laurentian University Federation Memorial Award to recognize the sacrifices of our soldiers and their families, of those who give their lives doing what we as a nation have asked of them.

The award will provide full-time Laurentian students tuition for up to four years of study, and free on-campus housing in Sudbury for the first year.

To be eligible, a student must be under the age of 26, a Canadian citizen or permanent resident, dependant of a Canadian Forces member killed while deployed on combat or peace support operations, and registered as a full-time undergraduate at Laurentian University in Sudbury or one of its federated universities. Application required.

### **Anne Crichton-George Scholarships (2)**

Established in 1998, in memory of Anne Crichton-George and her active involvement in Chapleau Ontario. Value: \$2,500/ea. Recipients: full-time 1st-year students from Chapleau, Ont. enrolled in any program (if there is no qualified applicant from Chapleau, the award may be given to a student from Northeastern Ontario). They must have achieved a min. average of 80% in an Ontario Secondary School (in six U/M courses), have demonstrated a broad range of interests and community involvement, as well as financial need. Renewable in subsequent years with acceptable academic standing. Students may receive this award in addition to other University financial aid. Application required.

### **Dowling Horseshoe Club Bursary**

A gift from the Dowling Horseshoe Club in recognition of the financial needs of students. The Club, founded in 1969, provided residents with an enjoyable competitive setting and contributed to the social fabric of the Dowling community for over 25 years. Value: \$1,300. Recipient: a full-time student from the Sudbury area (preferably a resident of Dowling), who is entering the 1st year of study, on the basis of financial need. Application required.

### **Gerald (KStJ) and Marguerite Lougheed Scholarship**

The Lougheed family is recognized in the region for its philanthropic accomplishments and commitment to caring for others. This scholarship was established in this spirit and to honour Gerry Lougheed Senior's Knighthood in the Order of St. John by Governor General Ray Hnatyshyn in 1990. Value: \$1,200. Recipient: a resident of the City of Greater Sudbury who has attained a min. 80% average in the secondary school examinations required for admission to the University. The student must present (1) a recommendation from the head of the Department of English or Français of their secondary school stating that he or she has demonstrated excellent literacy skills, and (2) a personal data sheet outlining community involvement. Application required.

### **LAAA-Alumni Association Faculty Entrance Scholarships**

Value: \$500/ea. Recipient: one student in each of Sciences/Engineering, Arts (Humanities or Social Sciences), Professional Schools and Management. Based on academic standing (min. 80%) in an Ontario secondary school (in six U/M courses) and financial need. Application required.

### **Sid Forster Memorial Award**

Established by family and friends of the late Sidney Clair "Sid" Forster as a tribute to his dedication and commitment to his family and community. Value: 5% of the endowment (\$650). Recipient: a 1st-year student enrolled in any undergraduate program. The student must: (1) have demonstrated the greatest improvement in academic standing in secondary school studies; (2) have made a contribution to her or his school or community; (3) have demonstrated financial need; (4) be a resident of the City of Greater Sudbury, and (5) receive the recommendation of a high school guidance counselor. Application required.



### **Nick Volf Engineering Bursary**

Value: \$580. Recipient: a full-time 1st-year student of Engineering, on the basis of financial need, and Ontario residency, as defined by OSAP. Application required.

### **Douglas Williamson Bursary**

Established to recognize the contributions of Dr. Douglas Williamson, a founder of the Department of Geology. Value: \$450. Recipient: a student entering the 1st year of the Geology program, on the basis of financial need and academic standing. Application required.

### **India-Canada Association of Sudbury Scholarship**

Value: \$500. Recipient: a full-time 1st-year student enrolled in any program. He or she must have achieved a min. 80% average in an Ontario Secondary School (in six U/M courses) and outline community contributions. Preference is given to dependents of members of the India-Canada Association of Sudbury, or other East Indian culture and heritage organization that shares the association's objectives. The student must present a personal data sheet outlining involvement or research interests in East Indian arts, culture, history and music. Application required.

### **Richard Pound SPAD Bursary**

Established by alumni, family and friends in attendance at the SPAD 35th Reunion celebration in 2007, the Richard Pound SPAD Bursary will be awarded to a student enrolled in the 1st year of the Honours Bachelor of Commerce in Sports Administration. Selection of the recipient is based on academic excellence (min. 80%) in an Ontario secondary school (6 best U/M courses). The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. Value is \$780. Application required.

### **Sudbury Canada-Wide Science Fair Scholarship**

Value: \$450. Recipient: a full-time 1st-year student enrolled in an undergraduate program in Sciences or Engineering, as selected by the Senate Committee on Undergraduate Academic Awards on the basis of academic achievement in secondary school. Preference is given to students who have previously participated in a science fair. Students must present a written recommendation from the high school guidance counsellor. Application required.

### **Thomas Balfe Memorial Award**

Established as a loving testament to Tom Balfe, a loyal son, brother and friend, by his family and friends. Tom had just started his first year in the Commerce program (1992-93) when he died suddenly in a car accident. Value: \$330. Recipient: a student entering the 1st year of the Commerce program, on the basis of financial need. Application required.

### **Michelle (Jane) Richer Memorial Bursary**

Established by family and friends in memory of the late Michelle (Jane) Richer, an outspoken person who was dedicated to her school, sports, work and friends, and applied herself with perseverance and determination for acceptance into the Kinesiology program before her tragic death in a car accident. Value: \$300. Recipient: a full-time student enrolled in the Kinesiology program, on the basis of financial need and demonstrated leadership qualities. Application required.

### **Dr. Frank J. Clumpus Bursary Fund**

Established by family and friends to commemorate Dr. Clumpus' term as Chair of the Board of Governors (1981-1984). Value: \$200 Recipient: a full-time 1st-year student from Northern Ontario, who has been an active volunteer and demonstrates financial need. Application required.

### **Christopher and Eva Doherty Bursary**

This award was established by their children to honor Dr. and Mrs. C.J. Doherty. Dr. Doherty served on the Laurentian University Board of Governors from 1960 to 1968 and was awarded an Honorary Doctorate of law by the University in 1985. The bursary is awarded to a student entering the first year of full time study with at least a "B" average. The student must maintain a minimum "B" average to continue receiving the award in subsequent years of study. Preference will be given to Northern Ontario students who are studying in a discipline in the health sciences, and can demonstrate financial need. Value is variable (up to full tuition). Application required.

### **John F. Mellaney Memorial Scholarship**

Established by Eldon Mellaney is to aid a student with financial need at the Laurentian University. The recipient must be enrolled in their first year of the Computer Science program and must have a minimum academic standing of 80% average in their final year of high school. If no qualified recipient, this award will be offered to a student in the Mathematics program. Application is required.

### **Laurentian University Faculty Association Scholarship**

Value: \$1000. Recipient: the son or daughter of a member of the CAW/Mine Mill and Smelter Workers Union, Local 598, entering the 1st year of any program with the highest overall average in the final year of secondary school. A high school guidance counsellor must provide a recommendation. Application required.

### **ENTRANCE AWARDS FOR WHICH AN APPLICATION IS NOT REQUIRED.**

**Listed below are all entrance awards for which NO application is required. The selection is done automatically, based on the specific criteria of the award and the entire pool of qualified applications.**

#### **KGHM Annual Awards - \$3000**

The “KGHM Scholarships” are awarded annually to one full-time student enrolled in the Geology program and one full-time student enrolled in the Mining Engineering Program. KGHM is a leading mid-tier copper mining company with corporate offices in Vancouver, B.C. and Toronto, Ontario. #### **Northern Ontario Awards - \$1000**

Awarded on the basis of academic standing (minimum 80%) to applicants residing in Northern Ontario.

### **Central Ontario Awards - \$1000**

Awarded on the basis of academic standing (minimum 80%) to applicants residing in Central Ontario.

### **Francophone Excellence Awards - \$1250**

This award has been created to encourage first year students to register in a program offered in French. Students must register in 24 credits, (i.e. 80% of a full course load) taught in French. To renew the award, students must maintain 80% in subsequent years, and register in a minimum of 24 credits taught in French.

### **Athletic Awards - \$3500**

Awarded on the recommendation of the athletic director and coaches to athletes admitted with 80% on high school grades.

### **Laurentian University Entrance Academic Excellence Awards**

**Each newly admitted student who just graduated from full-time studies at a secondary school and meets the criteria to be an Ontario Scholar (on 6 best U/M courses) is guaranteed an entrance scholarship. The value of the scholarship is as follows:**

**\* Calculating your average – For admission and award purposes, Laurentian University calculates admission averages**

based on the top six marks from grade 12 or level 4 U/M courses, regardless of prerequisites for the intended program of study (except Midwifery).

**To continue your scholarship at the same value, your average in subsequent years must remain within the same range as your admission average. If your average decreases, or increases in subsequent years, your award will be recalculated on the basis of the above scholarship grid.**

**Scholarship offers are extended on the basis of interim marks, and are renewable for a maximum of three additional years with the value in subsequent years based on the above grid. Application is not required.**

### **Dr. Judith Woodsworth President's Scholarship**

Established by Dr. Judith Woodsworth. The purpose of this award is to recognize excellence among students of Laurentian University. The recipient will be chosen among the new recipients of a National Dean's Scholarship for Excellence each year. Value: \$1,000. This scholarship is renewable for three years.

### **LAAA-Alumni Association Entrance Scholarship**

Value: \$2,500. Recipient: a full-time student entering the 1st year of any program, with a min. 70% average in a secondary school. Student must not be in receipt of any other awards from the University.

### **Board of Governors Scholarship**

Value: \$1,300. Recipient: a student entering the 1st year of a program in arts or science. The applicant must have obtained a min. 75% average in an Ontario secondary school (in six U/M courses) or the equivalent and must not be in receipt of any other major award.

### **Carl and Lyle Sanders Scholarships (2)**

Donated by the late Mr. and Mrs. Carl J. Sanders, Toronto-based business people and philanthropists. Value: \$2,200/ea. Recipients: 1st-year students enrolled in a Bachelor of Arts program, with a min. 80% average in an Ontario secondary school (in six U/M courses).

### **Carl J. Sanders Scholarships (2)**

A gift from the late Carl J. Sanders, a Toronto-based businessman with varied interests who, over the years, donated generously to educational institutions and charitable organizations. Value: \$1,200/ea. Recipients: 1st-year students enrolled in a Bachelor of Arts, Science or Commerce program, with a min. 80% average in an Ontario secondary school (in six U/M courses).

### **Concours provincial de français Entrance Prizes (2)**

Value: tuition fees. Recipients: the top two contestants in the Concours provincial de français secondary school language contest, enrolled in the 1st year of any program.

### **Concours de français - langue seconde Entrance Prizes (2)**

Value: tuition fees. Recipients: the top two contestants in the Concours de français - langue seconde secondary school language contest, enrolled in the 1st year of any program.

### **Dr. Edna L. Moore Entrance Scholarship**

A gift from the friends and colleagues of the late Dr. Edna L. Moore, the first Public Health Nurse in the Ontario Ministry of Health. Having been previously active in a national organization for public health nursing in the United States, she received an honorary doctorate degree from the University of Western Ontario in 1957. Value: \$280. Recipient: the 1st-year student enrolled in the School of Nursing with the highest academic standing. The student may not be in receipt of any other major award. The faculty of the School of Nursing makes the selection.

### **Edith Rose Brooks Memorial Award**

This award is given in memory of Miss Edith Brooks, through the Music Department, and will be awarded to a student in his/her first year of the music program with the highest overall standing in secondary school U/M courses. Value is variable.

### **Frank S. Ressel Memorial Scholarships (4)**

Established in 1990 by the late Frank S. Ressel of Sudbury. Value: \$1,000/ea. Recipients: 1st-year students enrolled in any undergraduate program on the basis of academic standing in an Ontario secondary school (in six U/M courses).

### **Horace J. Fraser Scholarship**

A gift from Mrs. Catherine Fraser in memory of her late husband, Horace J. Fraser, former President of Falconbridge Nickel Mines Ltd., esteemed member of the University's Board of Governors from 1960-1969 and Chair of the Board from 1965-1969. Value: \$2,000. Recipient: a full-time student entering the 1st year of any program, with a min. 80% average in an Ontario secondary school (in six U/M courses).

### **Laurentian University 35th Anniversary Scholarships (4)**

Value: \$1,000/ea. Recipients: 1st-year students enrolled in any undergraduate program, on the basis of academic standing (min. 80%) in an Ontario secondary school (in six U/M courses).

### **McIntosh Engineering Scholarship Fund & Stantec – Mining Scholarship for Academic Excellence**

Requirements: Established in 2009, these scholarships seek to award premiere students early in their years of study in the mining and mechanical engineering programs at Laurentian University. There are 44 awards in total valued at \$2800, to be disbursed over five years. First and second year students enrolled on a full-time basis are eligible.

### **Mr. and Mrs. Myer Levine Scholarship**

Established by their children, to honour Mr. and Mrs. Levine. Mr. Levine (1889-1973) was a local businessman and founder of Levine's Ladies Wear in Sudbury. Value: \$1,000. Recipient: a student entering the 1st year at University College. The applicant must have obtained a min. 75% average in a secondary school in Sudbury (in six U/M course) or the equivalent, demonstrate financial need, and not be in receipt of another major award.

### **Ontario Professional Engineers Foundation for Education Entrance Scholarships (2)**

Two scholarships, each valued at \$1,000, are awarded annually to outstanding students entering first-year Engineering at Laurentian University. Where possible, the scholarships are awarded to a female student and to a male student with the highest academic standing in an Ontario secondary school (six U/M courses). The scholarships are awarded on the recommendation of the School of Engineering.

### **Peter Barott Scholarship**

A gift from the friends, colleagues and associates of the late Peter Barott, a Montreal-based architect who designed major projects including the Science I Building at the University and who contributed to an Expo 67 project in collaboration with another architectural firm. Value: \$1,000. Recipient: a 1st-year student enrolled in the Engineering program, with a min. 75% average in an Ontario secondary school (in six U/M courses) and not in receipt of other scholarships or bursaries that exceed a total value of \$1,500. If no student entering Engineering is eligible, the award may be given to a student entering a science program.

### **R.J. Askin Memorial Scholarship**

Donated by Abitibi-Price Inc. (Toronto), in memory of the late Robert J. Askin, a former Governor of the University and a member of the Board from its inception until his death in 1961. Mr. Askin demonstrated a keen interest in the affairs of the University and contributed greatly to engineering. Value: \$700. Recipient: a 1st-year student enrolled in any program, on the basis of academic excellence in an Ontario secondary school (in six U/M courses).

### **Thayer Lindsley Scholarship**

A bequest of the late Thayer Lindsley (1882-1976), founder and former President of Falconbridge Nickel Mines Ltd. When he retired in 1956, Mr. Lindsley established the John Lindsley Trust which provides the funds for this award. Value: \$2,000. Recipient: a student entering a Bachelor of Science or Engineering program with a min. 80% average in an Ontario secondary school (on six U/M courses). The scholarship is paid in two installments: half at registration in 1st term, half at the beginning of the 2nd term.

### **Thomas D. Edward Scholarship**

Donated by Edwards Sudbury Ltd., in memory of the late Thomas D. Edward (1894-1971), its founder and former president, who had a keen sense of business and was actively involved in numerous local service clubs. Value: \$1,000. Recipient: a 1st-year student enrolled in a Bachelor of Arts, Science or Commerce, with a min. 80% average in an Ontario secondary school (in six U/M courses).

### **Walter Light Entrance Scholarships (1)**

Value: \$1,000. Recipient: 1st-year student enrolled in a Bachelor of Arts (Humanities) or Bachelor of Commerce, with a min. 80% average in an Ontario secondary school (in six U/M courses).



## **IN-COURSE AWARDS**

Unless otherwise specified, application deadline is June 1 of each year. Not all awards need to be awarded each year. The University may withdraw any award for which, in any year, no qualified applicant is found. In order that scholarships and bursaries may be equitably distributed, the committee reserves the rights to restrict the value of scholarships that any one student may receive. The committee also avoids the awarding of multiple scholarships wherever possible. #### **Mason C.F. Kossatz Memorial Scholarship**

**Requirements:** Established by the family, friends and colleagues of the late Mr. Mason C.F. Kossatz, who passed on in 1989, to commemorate his many contributions to his profession of mining engineering, a career that spanned four decades. Mr. Kossatz had always demonstrated a keen interest in the affairs of the University. Recipient: a student (Ontario resident) entering the 2nd year of the Mining Engineering program, based on financial need and academic standing (min. 70% overall average). The scholarship is paid in three installments - in 2nd, 3rd and 4th year of the program - providing the student maintains a min. 70% average. If he or she fails to do so, the remainder of the funds may be awarded to another qualified student. If, in any year, there is no qualified student, the funds will be donated to the library for the purchase of engineering books. The award is made on the recommendation of the School of Engineering and presented at an annual awards dinner. Application for In-Course Awards required.

**Value:** \$3200 for three years (total of \$9600).

### **Senator Rhéal Bélisle Scholarships (2)**

**Requirements:** Established by friends in honour of the 40th anniversary of Honourable Senator Rhéal Bélisle's dedication to public service. Mr. Bélisle devoted talent, time and energy to his community and country. He served his local community as Town Councillor and Mayor, then the Province as a member of the Legislative Assembly. From 1963 until his death in 1992, he served Canada as a Senator with great distinction and dedication. While he was a member of the Legislature, he guided the process that enabled the incorporation of Laurentian University of Sudbury, and of the University of Sudbury as a federated college. Recipient: full-time students entering the 2nd, 3rd or 4th year of specialized programs in Biology, Economics or Commerce. Based on academic standing in the previous year of study, demonstrated leadership and participation in the humanities, sports or arts, outside of the classroom. The awards are given alternately to francophone and anglophone students. Application for In-Course Awards required.

**Value:** \$1800/ea.

### **Marsh A. Cooper Award in Geology**

**Requirements:** a full-time student entering the 2nd year of the specialized Geology program, based on academic standing and financial need (in that order of priority). Selection is made on the recommendation of the Department of Earth Sciences. Application for In-Course Awards required.

**Value:** \$2000.

### **Dr. Baxter Ricard Scholarship**

**Requirements:** Established in honour of the late Baxter Ricard, LL.D. (Laurentian), former Chair of the Board of Northern Cable Services Ltd. and Mid-Canada Communications Corp. and Director of CUC Broadcasting Ltd. Recipient: a full-time student entering the 2nd, 3rd or 4th year of the francophone Commerce program with a min. 75% overall average, at least three courses taught in French in the previous academic year, and demonstrated leadership qualities. ## **Laurentian University Administrative and Professional Staff Association Scholarship**

**Requirements:** a student in any year of an undergraduate program on the basis of academic standing, demonstrated leadership qualities and significant contribution to the University community (must be detailed in writing). Application for In-Course Awards required.

**Value:** \$750

## **IODE Susan MacLachlan Memorial Award**

**Requirements:** a student entering the 2nd, 3rd or 4th year of a program in Education (B.A.), Nursing or Physical and Health Education. Based on academic standing (min. 75%) in the previous year and demonstrated leadership, active participation or volunteer work in the University or community. The student must not be in receipt of major awards from the University. Application for In-Course Awards required.

**Value:** \$750

## **Elizabeth Burton Award**

**Requirements:** student entering the 2nd, 3rd or 4th year of an undergraduate Science program, based on academic achievement and financial need. The award may be given to more than one student in the same year. Selection is made on the recommendation of the dean of Sciences and Engineering. Application for In-Course Awards required.

**Value:** 1-\$700 or 2-\$350 each

## **Pearl Hagen Memorial Awards (2)**

**Requirements:** A gift from the family, friends and colleagues of the late Pearl Hagen, an outstanding role-model in the practice of community nursing at the Sudbury and District Health Unit. Mrs. Hagen was the liaison with the University's School of Nursing and a valued friend and supporter. Recipients: full-time students (generic and RN) entering the 3rd or 4th year of the Bachelor of Science in Nursing. Based on academic standing and financial need. Application for In-Course Awards required.

**Value:** \$650/ea

### **Canadian Federation of University Women - Sudbury Awards (2)**

**Requirements:** Awarded to two female students entering 2nd and 3rd year respectively of any program, whether on a full time basis or registered for a minimum of two courses, on the basis of academic standing and financial need. Application for In-Course Awards required.

**Value:** \$500/ea

### **Canadian Federation of University Women (CFUW) - Helen Byrnes Memorial Bursary**

She was born in Spain and raised two children through the Spanish Civil War (1936-1939) and the postwar period. When her children immigrated to Canada, she did not hesitate to leave the country she loved so much. Recipients: full-time students entering the 3rd or 4th year of Modern Languages and Literatures, Spanish program. Selection is based on academic standing (min. 75%) and financial need. Application for In-Course Awards required.

**Value:** \$800/ea

### **Wallace Family Scholarship**

**Requirements:** awarded annually to a student entering the second year of the School of Engineering or the School of Commerce and Administration. The scholarship will be awarded on the basis of academic excellence, leadership qualities, and extra-curricular activities, including athletics. Prospective candidates may be required to attend an interview with a selection committee. This award may include, whenever possible, a summer work term with Pioneer Construction Inc. at the completion of year two. Application for In-Course Awards required.

**Value:** \$950

### **Dr. Janet Springer Memorial Scholarship**

**Requirements:** Established by the friends and colleagues of Dr. Janet Springer, a senior scientist with the Ministry of Northern Development and Mines who was keenly interested in encouraging young women to pursue non-traditional careers. **Requirements:** Established by the City of Greater Sudbury, friends and colleagues of the late Joe Fabbro to commemorate his numerous accomplishments as a businessman and local politician. Mr. Fabbro was a long-time mayor of the City and later, Chair of the Regional Municipality of Sudbury until his death in 1978. Recipient: a student residing in the City of Greater Sudbury who is entering 2nd, 3rd or 4th year of a general or specialized Bachelor of Arts in Political Science (min. 70% average in the previous year.) Must not be in receipt of any other major award. Application for In-Course Awards required.

**Value:** \$250

### **Anna Leone Taverna Memorial Scholarship**

**Requirements:** Established by the Taverna family and former pupils to commemorate Mrs. Anna Leone Taverna's keen interest in and love for education. She loved all children and taught Italian language and culture for more than 25 years. Recipient: a full-time student entering the 2nd year of the Italian studies degree program who

achieved the highest academic standing in their first Italian course of the previous year. Selection is made on the recommendation of the Italian studies program coordinator. Application for In-Course Awards required.

**Value:** \$330

### **Dr. Robert Williams Scholarship**

**Requirements:** Established by family and friends. The purpose of this award is to provide assistance to aid a student of Laurentian University who is enrolled in the Geology program who has achieved a minimum 75% average. Dr. Robert Williams, a retired Calgary surgeon, was 89 years old when he followed in the footsteps of his three granddaughters and graduated with a Bachelor of Science degree in geology from Laurentian University. The recipient must be a 2nd, 3rd or 4th year undergraduates enrolled in the Commerce, Economics or SPAD program. The recipient must be in good academic standing and demonstrate financial need. Value is \$1,000. Application is required.

### **Marc St-Laurent Commerce Award**

Established through planned giving, this annual award will offer financial assistance to a Francophone enrolled full-time in the 3<sup>rd</sup> or 4<sup>th</sup> year of the 4-year program of the School of Commerce and Administration. The student must have financial need, be a resident of Ontario as defined by OSAP and live in northern Ontario.

### **St-Aubin Ouellette Francophone Bursary**

This bursary, created through planned giving, is awarded to a full-time student in any program who is taking a majority of courses in French. He or she must demonstrate

financial need according to criteria established by Laurentian University's Student Awards Office, live in Northern Ontario and be a resident of Ontario, as defined by OSAP. Value is variable. Application is required.

### **Lamps 40th Anniversary (1969-2009) Bursary**

Established by the Laurentian Association of Mature and Part-Time Students (LAMPS). The purpose of this award is to provide financial assistance to a part-time student enrolled in any program at Laurentian University. Value is variable. Application is required.

### **John Krupp Memorial Bursary**

The John Krupp Memorial Bursary was established by Masha Krupp for Laurentian University's 50th anniversary in memory of John Krupp. A bursary in memory of a giving individual. John Krupp believed profoundly in two basic principles: that everyone deserves the education they need to pursue their life goals; and that all people have a moral obligation to give to those less fortunate than themselves. A hard-working miner from Sudbury whose own formal education ended after grade 4, Mr. Krupp and his wife raised six children, many of whom went on to post-secondary education. Mr. Krupp was also a deeply religious Baptist who donated at least 10 percent of his earnings every year to charity-regardless of his own financial challenges. Krupp's two bedrock principles fused in his contention that all people- not just in those who can afford it- have a right to higher education. This memorial bursary for a student in financial need is a fitting tribute to a quiet hero who had faith in human goodness and in all people's ability to improve their lives through learning. The purpose of this award is to provide financial assistance to a Laurentian University student enrolled in the Mining Engineering program to assist with the successful completion of university level studies. The bursary will be awarded on the basis of demonstrated financial need. Value is \$2,500. Application is required.

### **Department of Chemistry and Biochemistry Undergraduate Award**

Established by the Department of Chemistry and Biochemistry, family and friends. The purpose of this award is to provide assistance to a student of Laurentian University who is enrolled in the Chemistry or Biochemistry program. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **Department of English Faculty Bursary**

Established by faculty members of the Department of English. The purpose of this award is to provide financial assistance a student of Laurentian University who is

enrolled in the English program, and who is registered in ENGL 4105. The bursary will be awarded on the basis of academic excellence, demonstrated financial need, and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **Hector Sobol Memorial Bursary**

Established by family and friends, the purpose of this award is to provide financial assistance a student of Laurentian University who is enrolled in the 3<sup>rd</sup> or 4<sup>th</sup> year Nursing program. The recipient must have maintained a 75% average. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **Trebb Family Bursary**

Established by Laurentian University graduates Ronald and Mary Trebb as a tribute to their three sons Matthew, Andrew and Christopher Trebb who have also attended Laurentian University to inspire others to continue their education locally and in honour of Harry Trebb who strongly valued the pursuit of higher education. The purpose of this award is to provide financial assistance to a student of Laurentian University who is enrolled in any program and who is a resident of the City of Greater Sudbury. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **HAQ Family Bursary**

Established by family and friends. The purpose of this award is to provide financial assistance to aid a student of Laurentian University who is enrolled in any program at Laurentian University. Value is variable. Application is required.

### **Women's Association of the Mining Industry of Canada (WAMIC) - Wood Award**

Established by Women's Association of the Mining Industry of Canada (WAMIC) Foundation to encourage students to work or pursue a career in the geosciences industry. The purpose of this award is to provide scholarships to cover a minimum of \$6,000 towards tuition to aid students of Laurentian University who are enrolled in the 3<sup>rd</sup> or 4<sup>th</sup> year of the Bachelor of Science in Environmental Earth Science, Bachelor of Science in Earth Sciences, Bachelor of Engineering (Mining and Chemical), or Bachelor of Science in Environmental Studies (once approved). The bursary will be awarded on

the basis of academic excellence, minimum 80%, demonstrated financial need, and Ontario residency as defined by OSAP. Application is required.

### **SPAD 35th Alumni Awards**

Established by SPAD Alumni 35th Anniversary. The purpose of this award is to provide financial assistance to aid a student of Laurentian University who is enrolled in the SPAD program. This bursary is open to 2nd, 3rd or 4th year SPAD students. Two awards of approximately \$1,000/year. One for a 4th year student and one for a 2nd or 3rd year student. Minimum of 75% average in courses to date, high level of contribution to the program (SPAD Council, research, ISM work, events participation, volunteerism in sport/event management, etc.) & financial need required. A recommendation from the SPAD Director and at least one SPAD or Commerce professor is required. Value is variable. Application is required.

### **Derek Wilkinson Memorial Bursary**

Established by family and friends. The purpose of this award is to provide financial assistance a student of Laurentian University who is enrolled in the Bachelor of Arts of Sociology program. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **Ken and Denise Derrett SPAD Bursary**

Established by Ken and Denise Derrett. The purpose of this award is to provide financial assistance to aid a student of Laurentian University who is enrolled in the SPAD program. Students are to submit a short (500 word) essay with their application highlighting why they chose to enrol in SPAD and what they aspire to do with a SPAD degree. The recipient must be a resident of Ontario, as defined by OSAP. Value is variable. Application is required.

### **Trueclaim Exploration Inc Award**

Established by Trueclaim Exploration Inc., the purpose of the award is to provide financial assistance to a member of the Wahnapiatae First Nation enrolled at Laurentian University in the Environmental Studies, Earth Sciences or Engineering program. Applicants must provide proof of their status as a member of the Wahnapiatae First

Nation. In the event there are 2 student applicants enrolled in the mentioned programs, preference will be given to the student with the greatest financial need. An application is required.

### **Stonley Family Bursary**

Established by family and friends. The purpose of this award is to provide financial assistance a student of Laurentian University who is enrolled in any program. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **Bernie and Mary Langlois Family Bursary**

Established by Bernie and Mary Langlois to provide financial assistance to a student at Laurentian University. The recipient must be enrolled at the undergraduate or graduate level in the Faculty of Sciences and Engineering, Management, Medicine (registered through Laurentian University) or Architecture (once approved by LU senate). Where possible, preference will be given to a student who currently lives or previously resided in the Coniston area. If there is no qualified applicant from the Coniston area, the bursary will be awarded to a qualified student in the previously mentioned programs. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **Elizabeth Bonk Memorial Bursary**

Established by family and friends, this award is to aid a student at the Laurentian University. This scholarship will be awarded to the Concurrent Education Student who demonstrates the qualities of academic success, critical reflection, creativity and compassion in the Initial Practicum. The recipient must demonstrate financial need. Application is required. Value is variable.

### **Jeanne d'Arc Sullivan Memorial Bursary**

Established by family and friends. The purpose of this award is to provide financial assistance to a sole support parent studying at Laurentian University who is enrolled in the School of Education, (English program) or l'École des sciences de l'éducation. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **Kim Croteau Memorial Scholarship**

Established by family and friends in remembrance of Kim Croteau, a devoted mother of two who found the courage and determination to successfully acquire a university degree in Social Work as a mature student, while at the same time balancing the challenges of fighting cancer. Kim demonstrated sincere commitment to her vocation as a Social Worker, determined to put the needs of her patients before her own, even when her ailments made it difficult for her to continue working. The purpose of this award is to provide financial assistance to a mature student of Laurentian University who is enrolled in the Social Work program. The bursary will be awarded on the basis of demonstrated financial need. Value is \$1,000. Application is required.

### **Roland Bidal Bursary in French Education**

Established by family and friends. The purpose of this award is to provide financial assistance to a student of Laurentian University who is enrolled in the *École des sciences de l'éducation*, with academic excellence (minimum 80%). The bursary will be awarded on the basis of demonstrated financial need and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **French Language Teacher Education Program Bursary**

Established through planned giving, this award provides financial assistance to a full-time student enrolled in a program offered by the French-language School of Education. Students must demonstrate financial need, be Ontario residents as defined by OSAP, live in northern Ontario, have an overall average of at least 70% and take a majority of courses in French. Value is variable. Application is required.

### **Aimee Leonard Music Bursary**

Established by family and friends. In her short 27 years, Aimee Leonard released *What Happened*, an independently produced album, performed in various folk festivals, including Mariposa and Northern Lights Festival Boreal, was featured by CBC Radio 3 and touched many lives. "She was happy, precocious, good at everything, "She was a top student, good in sports, had lots of energy." But one thing that stood out about Leonard was her affinity for music. "She always loved music, always wanted to sing.



The purpose of this award is to provide financial assistance annually to a music student enrolled in either the BA or the BFA program, who demonstrates excellence in one or a combination of the following: academics, vocal performance and theatre arts. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **Peter and Shirley Moutsatsos Family Bursary**

Established by the Moutsatsos family. The purpose of this award is to provide financial assistance to aid a student entering any year of the Commerce program at Laurentian University. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. Preference will be given to a student who has attended high school in Sudbury. Value is variable. Application is required.

### **LUAA 50th Anniversary Bursary**

Established by the Laurentian University Alumni Association (LUAA). The purpose of this award is to provide financial assistance to aid a student of Laurentian University who is enrolled in a graduate program. The bursary will be awarded on the basis of demonstrated financial need, and Ontario residency as defined by OSAP. If no such student qualifies, the bursary will be awarded to a student in an undergraduate program. Value is variable. Application required.

### **Joro Photography Bursaries**

Value: \$500/ea. Recipients: students who are SGA members entering any year of any program, on the basis of financial need and academic achievement (min. 60% average). Application required.

### **Sudbury Wolves Community Club SPAD Bursary**

Established by the Sudbury Wolves Community Club. The purpose of this award is to provide financial assistance to a student of Laurentian University who is enrolled in the SPAD program. The recipient will be selected on the basis of demonstrated financial need and Ontario residency as defined by OSAP. Value is variable. Application is required.

### **John Partanen Estate Scholarship**

Donated by the John Partanen Estate Scholarship Trust Fund for the benefit of students in Mining. The scholarship will be awarded to students in the Mining Engineering program on the basis of academic standing and financial need. Bursary application is required.

### **Cousin Vinny's Restaurant Bursary**

Established by Tylor McNair and Chris Vitiello, both proud Alumni from Laurentian University and proud community members within the Greater City of Sudbury. Tylor and Chris who, at the establishment of this award, were the co-owners of Cousin Vinny's restaurant have created this bursary to support students in their studies. This award is presented annually to one full-time student enrolled in the Economics or Commerce program. The recipient must demonstrate financial need and must be a resident of Ontario with preference given to a resident of Northern Ontario. Value of the award is \$500. Selection of the award recipient shall be made by the Student Awards Office at Laurentian University. Application required.

### **Hillary Afelskie Memorial Bursary**

The ***Hillary Afelskie Memorial Bursary*** has been developed to honour the memory of this young woman's dream, from a very young age, to teach. This bursary is funded by the Bachelor of Education Student Association (B.Ed.S.A.) and will be awarded to an undergraduate Concurrent Education student. Applicants are required to submit a bursary application through the Student Awards office, as well as, submit a 500 word essay to the B.Ed.S.A. President on "how" they meet the criteria for this award. Hillary's caring spirit will live on as this award will help other aspiring teachers make a difference in the lives of others. Value of the award is \$500. Selection of the award recipient shall be made by the Student Awards Office at Laurentian University. Application required.

### **LAMPS Recognition Award**

The LAMPS Recognition Award has been developed to recognize Laurentian Association of Mature and Part-Time Student members who not only excel academically

but go above and beyond within the community. These awards are funded by the Laurentian Association of Mature and Part-Time Students (LAMPS) and are given annually to six part-time Envision or on-campus and/or full-time Envision students enrolled in any program at Laurentian University. Two awards will be presented for each session (fall, winter and spring) to total six awards per year. The recipients must be in good academic standing with a minimum average of 70% within the last semester. The recipients must demonstrate examples of strong community involvement and superior initiative within their participation in extra-curricular activities. Applicants are required to submit a letter indicating in detail how they meet the criteria for these awards.

Value of each award is \$700. Selection of award recipients shall be made by the Student Awards Office at Laurentian University. Application Required.

### **LAMPS Aboriginal Recognition Awards**

The “LAMPS Aboriginal Recognition Awards” have been developed to recognize Laurentian Association of Mature and Part-Time Aboriginal, First Nation, Metis and Inuit Student members who not only excel academically but go above and beyond within the community. These awards are funded by the Laurentian Association of Mature and Part-Time Students (LAMPS) and are given annually to three part-time Envision or on-campus and/or full-time Envision Aboriginal, First Nations, Metis and Inuit students enrolled in any program at Laurentian University. One award will be presented for each session (fall, winter and spring) to total three awards per year. The recipients must be in good academic standing with a minimum average of 70% within the last semester. The recipients must demonstrate examples of strong community involvement and superior initiative within their participation in extra-curricular activities. Applicants are required to submit a letter indicating in detail how they meet the criteria for these awards.

Value of each award is \$700. Selection of award recipients shall be made by the Student Awards Office at Laurentian University. Application Required.

### **Wendy Williams Bursary**

Established by Wendy and David Williams. The purpose of this award is to provide aid to a student at Laurentian University who is enrolled in any program. The recipient must demonstrate financial need. Preference will be given to students from farming families or whose parents work in the farming industry. Students should attach a short letter to explain how they meet the criteria (ie. their family’s agricultural background). Application in required. Value is variable.

### **Lucien Gervais Music Bursary**

Established by Lucien and Raymonde Gervais. This award is presented annually to one full-time student enrolled in the Music program. Preference will be given to a student who is specializing in piano and the recipient must demonstrate financial need.

The Political Science Department's Awards Committee will award this bursary. Application required.

### **Laurentian University Political Science Association (LUPSA) Model Parliament Bursary**

Established by the Laurentian University Political Science Association (LUPSA) in 2012.

Value: \$1,000

Recipient: a graduating student in Political Science who has demonstrated a commitment to Laurentian University's annual Model Parliament event during her/his time at Laurentian, and who is also in financial need. Applicants must submit a 1000-word essay on how Model Parliament has affected her/his social and academic development at Laurentian University. The Political Science Department's Awards Committee will award this bursary. Application required.

### **Blaine and Lise Nicholls Design Build Fund**

Established by Blaine and Lise Nicholls in celebration of the newly created School of Architecture at Laurentian University.

Blaine became a member of the Ontario Association of Architects in 1977 and was the project lead and driving force behind the establishment of the School of Architecture at Laurentian University. He has been responsible for a wide range of projects in Northeastern Ontario including: Science North, Health Sciences North, Pioneer Manor and the Northern Ontario School of Medicine at Laurentian University. Lise is a graduate of Laurentian University, having obtained her B.Sc Nursing in 1985.

The purpose of this award is to provide funding to a student(s), who is enrolled in the School of Architecture program and participating in the Design Build Studio. Recipient(s) will be selected at the discretion of the Director and will promote unique thinking, innovation and creativity. Value is variable. Application is required.

### **Mary Weaver, BA, LLB, QC Bursary**

Established by the John Carl MacIsaac Foundation to recognize Ms. Weaver's 20 years of outstanding service as a valued board trustee. Ms. Weaver's accomplished career in law commenced when she was called to the bar in 1951. Her remarkable history of community service was exemplified through the work she did while on Laurentian University's Board of Governors and as a bencher of the Law Society of Upper Canada. Ms. Weaver mentored many young women through her career and is a true role model and source of inspiration. Ms. Weaver is the namesake of the firm

Weaver Simmons LLP, and was the first female lawyer to practice law in Northern Ontario. She was also the first female partner in any law firm in the North. This bursary was created to benefit a first year female student enrolled in Laurentian's Engineering program demonstrating financial need. Value is \$2,000. Application is required.

### **Scotiabank Annual Award**

**“Scotiabank Award”** was established by Scotiabank to aid a student with a severe mobility or sensory impairment who is enrolled in any discipline at Laurentian University. The candidate must provide a letter with their application demonstrating a social commitment to the improvement of quality of life for people with disabilities. ### **The Sudbury Masters Running Club Award**

The recipient must have resided in Ontario for 12 months prior to beginning university studies. Selection is made on the recommendation of the Ennis family and the Student Awards Office. Application for Athletic Awards required.

### **The N.R.C.S. (Northern Rehabilitation and Consulting Services Inc.) Scholarships (2)**

Value: \$1,000/ea. Recipients: members of the men's basketball team registered as full-time undergraduate students, on the basis of academic standing in the previous year, and demonstrated leadership. Application for Athletic Awards required.

### **The Gino "Tepper" and Linda Caverson Scholarship**

Value: \$750. Recipient: a full-time undergraduate student who is a member of the University swim team, on the basis of academic standing in the previous year. Application for Athletic Awards required.

### **The Frederick Arthur "Wiggy" Walmesley Bursaries (4)**

Established by the late Thelma V. Walmesley in memory of her brother Frederick Arthur "Wiggy." Value: \$660/ea. Recipients: students entering the 2nd, 3rd or 4th year of any undergraduate program, on the basis of academic standing, financial need and participation in Interuni-versity Athletics. The recipient must have resided in Ontario for 12 months prior to beginning university studies. Application for Athletic Awards required.

### **The Joy Bellinger Memorial Scholarship**

Established by the family and friends of the late Joy Bellinger, a cherished alumnae and former Lady Veas basketball star. Value: \$600. Recipient: a female student entering the 2nd, 3rd or 4th year of a Bachelor of Physical Health Education who is a member of the Lady Veas basketball team, on the basis of academic standing in the previous year. Application for Athletic Awards required,

### **The F. Grant Henderson Bursary**

Value: \$500. Recipient: a member of the swim team registered in the 2nd, 3rd or 4th year of an undergraduate program, on the basis of financial need. The recipient must have resided in Ontario for 12 months prior to beginning university studies. Selection is based on the recommendation of the Student Awards Office. Application for Athletic Awards required.

### **The Joey Jerome Memorial Award**

### **The Max Silverman Memorial Scholarship**

Established by friends, relatives and colleagues of the late Max Silverman to commemorate his accomplishments as a Sudbury businessman, sportsman and mayor. Value: \$190. Recipient: a member of the Interuniversity Athletic Program who is registered in the 2nd or 3rd year of a Bachelor of Physical and Health Education on the basis of academic excellence. If no qualified applicant is found, the award may be given to a member registered in any program. Application for Athletic Awards required.

### **The Roman Baumann Memorial Scholarships (2)**

Roman was a founding member of the swim club, was named Voyageur Athlete of the Year on three occasions, was an Ontario and Canadian University champion and represented Canada on the National Swimming Team. ### **The Don Punch Memorial Award**

Inaugurated by Joanne Derks and the Frank Bell family, and supported by Don Punch's family and friends, this award was established to help varsity athletes. As a former basketball player, CIAU and secondary school coach in Northern Ontario, Don's love of the game and concern for athletes is well documented. Value: \$120. Established by Peter Hellstrom and Virgil Hill of the Athletics Department. The recipient(s) must be a member of the Voyageurs men's basketball team.
